



DECREE OF THE MINISTER OF MARINE AFFAIRS AND FISHERIES OF THE
REPUBLIC OF INDONESIA
NUMBER 4 OF 2023
CONCERNING
DETERMINATION OF BASE PORTS THAT HAVE FULFILLED THE POST-
PRODUCTION WITHDRAWAL REQUIREMENT FOR THE TYPE OF NON-TAX
STATE REVENUE WHICH ORIGINATE FROM UTILIZATION OF FISHERIES
RESOURCES

BY THE GRACE OF GOD ALMIGHTY

THE MINISTER OF MARINE AFFAIRS AND FISHERIES OF THE REPUBLIC OF
INDONESIA,

- Considering :
- a. that the base ports that have been stipulated in the Decree of the Minister of Marine Affairs and Fisheries Number 50 of 2022 concerning Determination of Base Ports that have Fulfilled the Post-Production Withdrawal Requirements for the Type of Non-Tax State Revenue which Originate from Utilization of Fisheries Resources are not yet able to accommodate the needs of fishing vessels landing fish at the base port that meet the post-production withdrawal requirements, so they need to be replaced;
 - b. that based on the considerations as referred to in letter a, it is necessary to stipulate a Decree of the Minister of Marine Affairs and Fisheries concerning Determination of Base Ports that have Fulfilled the Post-Production Withdrawal Requirements for the Type of Non-Tax State Revenue which Originate from Utilization of Fisheries Resources;

- In view of :
1. Article 17 paragraph (3) of the 1945 Constitution of the Republic of Indonesia;
 2. Law Number 39 of 2008 concerning State Ministries (State Gazette of the Republic of Indonesia of 2008 Number 166, Supplement to the State Gazette of the Republic of Indonesia Number 4916);
 3. Government Regulation Number 85 of 2021 concerning Types and Tariffs for Non-Tax State Revenues Applicable to the Ministry of Marine Affairs and Fisheries (State Gazette of the Republic of Indonesia of 2021 Number 188, Supplement to State Gazette of the Republic of Indonesia Number 6710);

Presidential Regulation Number 63 of 2015 concerning the Ministry of Marine Affairs and Fisheries (State Gazette of the Republic of Indonesia of 2015 Number 111) as amended by Presidential Regulation Number 2 of 2017 concerning Amendments to Presidential Regulation Number 63 of 2015 concerning the Ministry of Marine Affairs and Fisheries (State Gazette Republic of Indonesia of 2017 Number 5);
5. Regulation of the Minister of Marine Affairs and Fisheries Number 48/PERMEN-KP/2020 concerning the Organization and Work Procedure of the Ministry of Marine Affairs and Fisheries (State Gazette of the Republic of Indonesia of 2020 Number 1114);

DECIDE:

- Stipulate** : **DECREE OF THE MINISTER OF MARINE AFFAIRS AND FISHERIES CONCERNING DETERMINATION OF BASE PORTS THAT HAVE FULFILLED THE POST-PRODUCTION WITHDRAWAL REQUIREMENT FOR THE TYPE OF NON-TAX STATE REVENUE WHICH ORIGINATE FROM UTILIZATION OF FISHERIES RESOURCES**
- FIRST** : Determine the base ports that have fulfilled the post-production withdrawal requirements for the type of non-tax state revenue originate from utilization of fisheries resources as listed in the Appendix which is an integral part of this Ministerial Decree.
- SECOND** : At the time this Ministerial Decree comes into effect, Decree of the Minister of Marine Affairs and Fisheries Number 50 of 2022 concerning Determination of Base Ports that have Fulfilled the Post-Production Withdrawal Requirements for the Type of Non-Tax State Revenue which Originate from Utilization of Fisheries Resources, is revoked and declared invalid.
- THIRD** : This Ministerial Decree shall come into force on the date of stipulation.
